A. Details of Qualification Requirement for Engagement of Manpower

1. SENIOR ENERGY CONSULTANT – EC (Energy Conservation & Energy Efficiency)

Number of Posts: 1

Number of post for Senior Energy Consultant - EC (Energy Conservation & Energy Efficiency) is 1 (one) and shall be engaged in Uttarakhand Renewable Energy Development Agency (UREDA).

Minimum eligibility criterions

Essential:

- i. Maximum age limit of the candidate should be 45 years as on 31/05/2023.
- ii. AICTE / Govt. approved Bachelor Degree in Engineering with minimum of 60% marks or equivalent grade in the engineering degree examination.
- iii. Minimum 5 years post qualification experience in energy efficiency or energy conservation and energy auditing as on 31/05/2023.
- iv. BEE certified Energy Auditor/ Energy Manager having experience of handling activities related to DC.

Remuneration

- i. Consolidated remuneration amount – Rs.63,000/- per month as per terms & conditions of the Agreement. EPF & Income Tax shall be deducted as per rules from the consolidated amount.
- ii. The TA/DA Shall be applicable as per the Uttarakhand Government rules.

B. Details of Scope of Work

1. Scope of work for the post of Senior Energy Consultant (EC)

Facilitate smooth and timely implementation of activities under Perform, Achieve and Trade (PAT) scheme of BEE

PAT is a market based mechanism under the National Mission for Enhanced Energy Efficiency (NMEEE) to enhance cost effectiveness of improvements in energy efficiency in energy-intensive large industries and facilities in energy intensive industrial sectors, through certification of energy savings that could be traded.

The Senior Energy Consultant (EC) is expected to perform the following roles for smooth implementation of PAT scheme:

- Rule 5 – Form, manner and time for preparation of scheme for implementation of efficient use of energy and its conservation: Guidelines may be provided to SDAs detailing the actions to be undertaken on the action plan submitted by the DC.
- Rule 6 – Assessment of performance: For sub-rule (7) under rule (6), format and guidelines may be provided to SDAs for furnishing comments on Form ‘A’ to BEE.

- Rule 8 – Check Verification: For sub-rule (2a) & (11) under rule (8), format and guidelines may be provided to SDAs for furnishing comments to BEE.
- Rule 8 – Check Verification: For sub-rule (14) under rule (8), guidelines specifying the procedure to be adopted and the official responsible to initiate penalty proceedings may be provided to SDAs.
- Rule 8 – Check Verification: For sub-rule (15a) under rule (8), guidelines may be provided to SDAs detailing the actions to be undertaken to recover from the DC the loss to the Central Govt. by way of unfair gain to the DC.
- Rule 13 – Compliance of energy conservation norms and standards: Guidelines detailing the action to be taken by the SDA regarding submission of compliance as per Form ‘D’ by DC.
- Any other data/information sought by BEE as and when required.

In addition to the above, the Senior Energy Consultant (EC) will be required to do any other task pertaining to schemes of BEE and other schemes as per direction provided by Director, UREDA.

2. Selection Criteria

Senior Energy Consultant (EC)

1. All the candidates fulfilling the minimum eligibility criteria shall be called for interview.
2. UREDA shall display the date of interview and the list of shortlisted candidates for interview in UREDA’s website www.ureda.uk.gov.in after verifying the documents and application submitted by the candidates.
3. The final selection of candidate shall be based on the interview performance.
4. Candidates are advised to keep a track of UREDA website for information regarding the selection.
5. Director UREDA reserves the right to accept/reject any applicant or cancel the recruitment without assigning any reason.

4. Terms and Conditions

The Senior Energy Consultant (EC) shall abide with the following:

1. The Senior Energy Consultant (EC) shall be stationed at UREDA headquarter, Dehradun.
2. The selected manpower shall report to Officer In-charge, UREDA as per their posting.
3. The selected manpower may be called upon to attend office on holidays / Sundays in the interest of work.
4. UREDA shall pay the remuneration of Senior Energy Consultant (EC) on a monthly basis.
5. Employment will be purely on contractual basis and initial contract would be for a period 30th September, 2023. The contract may be further renewed on an annual basis with mutual agreement.
