1. The Solar plant shall fulfill the criteria of behind the meter Captive solar Power Plant as defined in the Electricity Rules 2005 notified under The Electricity Act, 2003 and amend time to time.
2. I/we shall be responsible for planning, design, construction and safe and reliable operation of its own equipment's in accordance with the Central Electricity Authority (Technical Standards for Connectivity to the Grid) Regulation, 2007, Central Electricity Authority (Technical Standards for Construction of electrical plants and electric lines) Regulations, 2010, Central Electricity Authority (Grid Standards) Regulation, 2010, Uttarakhand Electricity Regulatory Commission (State Grid Code) Regulations, 2016 and any other applicable Regulation/Act/Law as amended from time to time.
3. I/We shall be solely responsible for any incidents/accident to human being/animals whatsoever (fatal/nonfatal/departmental/non-departmental/damages to material of UPCL) that may occur due to back feeding from the solar plant when the grid supply is off and we shall not only bear the cost of the damages to the material of UPCL but also compensate for the life of any human being/animals in case of such incidents/accidents. UPCL reserves the right to disconnect the consumer's installation at any time in the event of such exigencies to prevent accident or damage to man and material.
4. I/We shall ensure that at any time throughout the period of connection, no power shall be injected in the Licensee's grid (installation of reverse power protection relay or any advance mechanism mandatory to install). In case of any breach, UPCL/UREDA shall have to liberty to disconnect the said plant without any notice to the company. Moreover, no payment or benefit whatsoever shall be given to the company for any such injection.
5. I/we Shall be ensure that the installation shall be inspected and certified by Electrical Safety Department, Government of Uttarakhand before first time synchronization/cod of the plant for safety of plant and machinery.
6. Apart from the above, if any time i/we found violating of any condition/regulation/order issued by Hon'ble UERC/UREDA/UPCL, UREDA will cancel the allotment and inform to UPCL for necessary action.
